Assignor shall not alter or amend the Contract without the prior written consent of Lender. Unless and until a default shall occur under the Loan or under any of the Loan documents, Lender shall not exercise any of Assignor's rights under the Contract and Assignor shall have the right to use or possess the plans, specifications, drawings, and models referred to above, provided, however, that from and after the time of any such default, Lender immediately shall become entitled, but shall not be obligated, to exercise all the rights of Assignor under the Contract and to take possession of and to make full use of the plans, specifications, drawings, and models. Lender shall not be liable for any defaults by Assignor in the performance of Assignor's duties under the Contract, and Assignor hereby agrees to indemnify, save harmless, and defend Lender against any and all claims, damages, liabilities, and losses, including attorneys' fees, arising out of any such default.
