Assignor warrants with respect to each Contract that: (a) there has been no prior assignment of the Contract; (b) the Contract is a valid, enforceable agreement; (c) neither party is in default to the other under the Contract; and (d) all covenants, conditions, and agreements have been performed as required in the Contract, except those not due to be performed until after the date of this Assignment. Assignor shall not alter or amend any of the Contracts without the prior written consent of Lender. Unless and until a default shall occur under the Loan or under any of the Loan documents, Lender shall not exercise any of Assignor's rights under the Contracts; provided, however, that from and after the time of any such default, Lender immediately shall become entitled, but shall not be obligated, to exercise any rights of Assignor under the Contracts. Lender shall not be liable for any defaults by Assignor in the performance of Assignor's duties under the Contracts, and Assignor hereby agrees to indemnify, save harmless, and defend Lender against any and all claims, damages, liability, and loss, including attorneys' fees, arising out of any such default.
